Resort Guidelines Agreement

1. The Scottish Deerhound Club of America authorizes Basin Harbor Club to collect any fees for any damages to the accommodations by the dogs or the attendees. Basin Harbor Club will be responsible for reporting the damages and costs to the individuals and posting the charge to their credit cards. The Basin Harbor Club will also report damages to a representative of the Scottish Deerhound Club of America in order for the SDCA to make a report to the American Kennel Club, if warranted.
2. A \$50.00 per unit damage deposit will be taken prior to check in. After check out, the accommodation will be inspected for damage, and if none is found the \$50.00 will be returned. If there is damage, the cost to repair it will be deducted from any deposit paid. A written explanation of the charges will be sent to the individual. The damage deposit is not applicable to RV stays.
3. All dogs must be crated when unattended in the accommodations.
4. All attendees are responsible for “picking up” after their own dogs while on Basin Harbor property.
